During May let's continue our local, regional and statewide collaboration within the VLGMA framework of V= leading with our Vision, Values and L= for delivering strong community-based and collaborative Leadership. Our commitment to the best interests and dignity of people is reinforced in three Code of Ethics tenets to ponder this month:

Tenet 2. Affirm the dignity and worth of local government services and maintain a deep sense of social responsibility as a trusted public servant.*

Tenet 4. Serve the best interests of the people.*

Tenet 5. Submit policy proposals to elected officials; provide them with facts, and technical and professional advice about policy options; and collaborate with them in setting goals for the community and organization.

As in past articles let's continue to connect these tenets to the Declaration of Ideals (adopted in the early 1980s, https://icma.org/declaration-ideals). Of the eleven ideals two are aligned with the above tenets:

Ideal 4. Seek balance in the policy formation process through the integration of the social, cultural, and physical characteristics of the community.

Ideal 7. Promote a balance between the needs to use and to preserve human, economic, and natural resources.

To translate these tenets and ideals into the intersection of our professional and personal roles can you answer "yes" to these questions even when hard to balance the day to day work requirements and pandemic mitigation responsibilities? Consider:

- 1. Have you and the governing body established the next phases of COVID-19 recovery?
- 2. Have you and your governing body established service and financial guiding principles for deploying the ARPA funding?
- 3. Have you established a cross-functional team to develop the spending plan? What is the community engagement component?
