
#### PRINCIPLES IN REAL LIFE

#### THE NEW LESSON PLAN?

#### **POLITICAL NEUTRALITY**

Refrain from all political activities which undermine public confidence in professional administrators.

Personal Advocacy of Issues.

Members share with their fellow citizens the right and responsibility to voice their opinion on public issues.

Members may advocate for issues of personal interest only when doing so does not conflict with the performance of their official duties.

# WHAT IMPACT DOES VOICING YOUR OPINION HAVE ON YOUR ROLE?

- Convenor or facilitator on community issues
- Neutral mediator to resolve disputes
- Source of facts, objective and credible recommendations
- Service provider

The learning/adjustment curve with the new manager is steep and just a bit challenging. The management team is committed to "getting onboard". The leadership style differs from the former manager.

#### Of concern:

- Interactions with staff that are "off",
- Questionable expenditures and travel reimbursements,
- Hiring under qualified people for high level positions

Describe your approach. Do you ignore? Talk with the manager? Go to others? Leave?



You enthusiastically accepted an offer of employment for a city manager position and council approved your agreement. You gave your 30 day notice.

A week later, the media reports the mayor was indicted. Relates to development deals in the city. A council member is implicated as well.

Never disclosed during the recruitment. You have <u>HUGE</u> concerns about joining this organization.



- Council members are elected by ward to represent the town
- Your child's lacrosse coach, aka the mailman, tells you that he is pretty sure councilmember Wilson doesn't live in her ward
- The council member owns two homes and one of them doesn't get mail delivery

With this information in hand, is the town manager ethically obligated to act?

If so, how? Investigate? Talk with the council member? Talk with the mayor or president of council?



Your first year as county manager was fantastic!

Beginning of year two, not so good. Militant group harassing elected officials and staff, disrupting public meetings, running a slate of candidates, flooding social media with false info.

Incumbents decline to run for re-election. Your assistant quit.

If the militants win seats, you are done. Should you start looking for a new position now?



#### PRINCIPLE IS INCONVENIENT

"It's this gap between the short-term and the long-term that makes a principle valuable. If your guiding principle is do whatever benefits you right now, you don't have principles of much value.

But it's the valuable principles that pay off, because they enable forward motion, particularly when it feels like there are few alternatives.

We embrace a culture based on principles because it's that structure and momentum that enables connection and progress to happen in the first place."
